Fully serviced and ready for development, this property includes completed site prep, landscaping, riparian work, and permits, with dock approval pending, Zoned Recreational Commercial (C5) for Mobile Home. RV, and Campground uses, current plans call for 44 pads with an amenity building, pool, hot tub, indoor golf simulator, common washrooms, and maintenance building. A 2,377 SF home with large patio and 1,000 SF garage/shop is included and planned to form part of the amenities building. Connections for water, natural gas, electricity, and future sewer are in place. Ideally located next to Swan Lake Market, across from Splashdown Waterpark, and minutes from Vernon's commercial hub, with potential for strata development or alternative uses approved by RDNO. Investment package available with signed NDA, including detailed plans and documentation of over \$1.5M in completed site, landscaping, and riparian work.


## THE COMMUNITY
